The market growth is majorly attributed to the increasing importance to mobility. The industrial growth is supported by the rise in demand for foreign talents from countries like the U.S., UK, Canada, and others. However, strict immigration laws by regional governments hinder the growth of the global marketplace. For instance, in a recent announcement on immigration plans, Canada expects around 1,233,000 new permanent residents over the next three years to help in economic recovery after the hit of the pandemic. Immigration is becoming more critical to employers as high-skilled labour shortages intensify in both the U.S. and globally. Last year's Immigration Trends Report found that 85% of employers expect their company's foreign national headcount to increase or remain the same in the next year, a 6% increase from 2019. Meanwhile, it has become clear that organizational diversity plays a significant role in the competition for talent: 40% of employers reported that recruiting a diverse workforce was the primary driver in the growth of their immigration work, the single largest reason among respondents.
